

## U.S. NATIONAL ADAPTATION AND RESILIENCE PLANNING STRATEGY

The new National Adaptation and Resilience Planning Strategy provides a blueprint for the United States to adapt to and prepare for the current, near-term, and long-term effects of climate change. The Strategy highlights four key components for adaptation planning: climate risk and vulnerability assessments, planning and identification of adaptation options, implementation of polices and programs, and effective monitoring evaluation, and learning.






#### NOAA NCEI'S YEAR-END 2024 GLOBAL CLIMATE REPORT
